Rashmi Gangamma, PhD (she/her)

My educational foundations in Psychiatric Social Work in India, and my subsequent education, research, teaching, practice, and leadership in MFT in the United States inform my social justice lens in family systems

therapy. I believe that we, as family systems therapists, have a unique responsibility to promote relational healing and authentic dialogue, especially in contexts of systemic oppressions, disruptions, intergenerational trauma, and profound grief. This belief has been a guidepost in my work with individuals and families with experiences of complex traumas of forced displacement and systemic, identity-based oppression.

Collaboration, relationship building, and an openness to diverse, multiple perspectives define my work as a scholar, faculty member, and a program director. For instance, during my tenure at Syracuse University, I led a team of graduate students and partners in academia and community agencies to establish co-located family therapy services for resettled refugees, strengthen curriculum to increase therapist competencies, and conducted interdisciplinary research with implications for shifting refugee resettlement policies.

In my current role as a program director of a newly accredited CFT program at the University of Colorado, Denver, I work similarly, collaborating with faculty and university administrators to better support our students, increasing our program's recognition, and advocating for resources in these challenging times in higher education.

Recent advances through the tireless work of Family Team and AAMFT leadership have led to increased access and recognition at national levels. I am optimistic about our future directions and will work hard towards further fulfilling our strategic vision to enhance our profession's reputation, parity, and ensure rigorous education and training. As your board member I will also work to amplify diverse, minoritized voices in guiding the future trajectory of our profession.
